Summary of the views expressed at the Workshop for the Executive Committee of the Commission on Strategic Development held on 4 April 2006

The purpose of the workshop was to provide a forum outside regular meetings for Members to exchange views on how to enhance Hong Kong's international competitiveness, so as to facilitate further discussion on the subject at future Committee meeting(s).

2. Two speakers were invited to give presentations on the topics concerned:

3. Salient points of discussion following the presentations are summarized in the ensuing paragraphs –

Financial Services

Commerce

• A speaker viewed that Hong Kong had great potential to become the world's largest stock market if Mainland enterprises chose Hong Kong as the primary location to launch their Initial Public Offerings. It was also highlighted that an active equity market with high trading volume attracted fund management activities. It would create a lot of business and employment opportunities and gain ground for Hong Kong to position itself as a regional fund management centre.

- A member echoed that the equity market in the Mainland was still largely untapped. If residents in the Mainland were allowed to trade Hong Kong stocks using RMB through an agent to be authorized by the Hong Kong Stock Exchange, the turnover would be enormous and would also benefit the business and economy of Hong Kong.
- It was also considered important to further develop the bond market in Hong Kong so as to strengthen the position of Hong Kong as the centre of finance and trading which provides comprehensive investment instruments and financial services.
- A member opined that RMB could become freely convertible in the near future. If that happened, few foreign investors would wish to keep Hong Kong dollars to avoid unnecessary risks involved in currency exchange. He therefore suggested changing the trading currency in Hong Kong to US dollar.
- A speaker remarked that Hong Kong should benchmark with those countries in direct competition with Hong Kong. Hong Kong should also develop RMB business, trading business and bond market in order to solidify its position as an international financial centre.

Human Capital

- There was a common view among Members underlining the importance of human capital and human resources as highlighted in a speaker's presentation.
- It was noted that the comparative advantages of Hong Kong depended significantly on the international exposure and command of English of Hong Kong people. It was generally agreed that Hong Kong should improve the standard of English of our population, as it was the key to connect to the rest of the world.
- Apart from the standard of English, it was also pointed out that Hong Kong should emphasize improving the standard of Chinese, particularly Putonghua. It would be crucial for Hong Kong to

maintain its position as the centre for international business transactions.

- A number of members suggested increasing the percentage of non-local students in the higher education in Hong Kong, since non-local students could help widen the horizon and increase the international exposure of local students. If these students stayed and worked in Hong Kong after study, they would become part of the talent pool in Hong Kong. Even if these students left Hong Kong after graduation, they might help promote Hong Kong and enhance the understanding of foreign countries about Hong Kong.
- Another member echoed that Hong Kong should consider developing into an education hub and provide education services to overseas students. It was suggested that the Government could consider providing tax relief or concession on land premium as incentives.
- A member suggested to consider revitalizing the traditional manufacturing industries as these industries could accommodate people who had low education standard and skills.

Public Governance and Political Development

- A speaker took the view that with an imperfect political system but a well-developed media, the governance in Hong Kong was understandably very difficult. In order to be more competitive, it was necessary for Hong Kong to have a harmonious society and a mature political system. The Government should maintain a close liaison with people with different interests in the society, for example, the business community, with a view to having their concerns duly addressed and maintaining the stability and harmony of the society.
- A member felt that Hong Kong should reform its political system so that the Chief Executive could have more political allies in the legislature to support the government's policy and fiscal proposals.
- The majority of the members agreed that one of the main advantages of Hong Kong over other cities in the Mainland was the rule of law.

Members opined that the rule of law and freedom of press should be upheld in order to maintain the competitiveness of Hong Kong.

Environmental Concerns

- There was a common view that Hong Kong would need to have a better physical environment so as to maintain its international competitiveness and attractiveness to tourists as well as talents.
- It was agreed that more efforts should be devoted to tackling environmental issues in Hong Kong, in particular the air pollution problem. The Government might consider setting up a designated bureau to handle environmental issues.
- Since Hong Kong people owned a large number of factories in the Pearl River Delta region, there was a suggestion that the Government should liaise with the relevant sectors and formulate measures with a view to alleviating the air pollution problem in the region.

Concluding Remarks

4. Head of the Central Policy Unit expressed gratitude to the speakers and all Members for their suggestions and comments. He welcomed further comments from Members either through email or fax to the Secretariat for distribution to other Members. The Secretariat would prepare a summary of views expressed at the workshop for Members' reference.
